

## **Chief Executive - Indicative Terms & Conditions of Employment**

Annual Salary	Up to £150,000 per annum.
	Commencing salary subject to negotiation and agreement with the successful candidate.
<b>Contract Term</b>	Permanent Contract.

Continuity of Employment	<ul> <li>Previous continuous service within local government recognised by TfN (as per the Redundancy Modification Order).</li> </ul>
Working Hours	Normal business hours are 37 hours per week. You will be expected to work flexibly to meet business needs, within UK legislative boundaries.
Place of Work	Flexible but with a requirement to regularly work from our offices in Manchester.
Notice period	Six months' notice required on both the employee and employer sides.
Pension	Membership of the Local Government Pension Scheme. No loss of continuation of service if already working in Local Government.

Occupational Health & Employee	Occupational Sick Pay - Above statutory minimum entitlements, up to 6 months full pay and 6 months half pay.
Assistance	Free independent support and advice in matters relating to health in the workplace.
	Free 24/7 advice on any challenges you encounter in life from moving home to family crises.
Occupational Maternity, Paternity or Adoption Leave	Above statutory minimum entitlements.
Bereavement Leave	<ul> <li>Immediate family or close relations: Up to 5 days' paid leave.</li> <li>If responsible for funeral arrangements: Up to a further 5 days' paid leave.</li> </ul>
Cycle to work Scheme	• Cycle to Work Scheme - Cycle & equipment purchase up to £3,000 and TAX and NI savings via salary sacrifice.
Facilities (Leeds & Manchester Offices)	Secure cycle storage points and free shower facilities at both of TfN's main offices in Leeds & Manchester offices.
Relocation Allowance	<ul> <li>This post is eligible (subject to certain conditions) to claim a relocation allowance of up to £8,000 during the first year of employment.</li> </ul>
